**Excerpts From The NTCA Bylaws**  
Requirements For Full Membership

**1. FULL MEMBERSHIP**

Full Membership will be achieved by completion of Associate Membership or by special action of the Membership Committee with approval of the Board. Full Membership shall be re-certified five years after attaining Full Member status per Bylaws section 1-D. Thereafter, Full Membership shall be maintained by payment of dues.

The qualifications of Full Member shall include all the requirements of the other classifications plus:

- A. Must be actively calling twenty-four full programs of patter and singing calls for a regular club(s) in the previous twelve months or, conducting twenty-four full round dance, clogging or contra dance programs in the previous twelve months. Up to six Community Dance Programs or "one-night stands" may be substituted for a like number of dances. Must teach or help teach a minimum of one square dance, round dance, clogging, or contra class in the previous twelve months. Teaching a second set of lessons may be substituted for six of the required twenty-four dances.
- B. A Full member must attend fifty percent of the association's functions each year. This includes workshop sessions and general meetings.

A Full Member shall receive all benefits of the association, including the right to vote, to serve on any committee, and to become a candidate for the Executive Board.
